Water Department News...

During the days following Hurricane Sandy an e-mail message came from our licensed operator, Gerald Kastner to the Water Dept. Administrator clearing any misinformation:

Barbara:

Please be advised that there was never a contamination issue during the Hurricane Sandy power outages and subsequent low water pressure occurrences.

It was brought to my attention that NJDEP had posted on-line, a boil water advisory for

our system. This was a precautionary advisement issued without my knowing. Having contacted me, they removed the advisory the following day. Brookwood's water has been and currently remains in compliance with all NJDEP regulations. I hope this clears up any concerns.

Basic Service Rate Increase

The Water Department has made every attempt to keep a lid on costs; however, the cost of doing business has increased.

Increased operating expenses include the costs of property taxes, postage, electricity, pipe repairs, laboratory fees, salaries and insurance. In addition, there are vacant (non-paying) homes in the development. To continue quality of service to our water customers, starting January 2013, we must increase basic service by \$3.00 per month for residential customers and \$4.50 per month for commercial customers. There will be **no** rate increase for water usage.
