Late Payment and Statement Fees
 Payment for Water Service is due on/before
 The billing due date. Past due accounts are
 subject to fees and termination of service.

Easy Pay Plan

An Easy Pay Payment is available to Water
 Service Customers who are unable to pay
 their water service bill in full within 30
 days.

Easy Pay Plan customers are not subject to
 statement or late fees as long as they pay
 1/3 of their bill by the 25th of each month.
